Item No. 3 : **To decide Review Application of Dr. Zakir Hussain Education Society Nanded's Aurangabad Nursing School, Aurangabad at 11.00 am as per the direction of High Court.**

In the matter of review application filed by Dr. Zakir Hussain Education Society Nanded's Aurangabad Nursing School, Aurangabad .

Dr. Zakir Hussain Education Society Nanded's Aurangabad Nursing School, Aurangabad, the applicant submitted fee proposal to the erstwhile Shikshan Shulka Samiti for the AY 2015-16. According to the applicant, they are entitled to collect fees @ Rs.81,300/- from each student during the AY 2015-16. The Shikshan Shulka Samiti after going through the balance sheet and other documents submitted by the applicant, fixed Rs. 41,480/- for the AY 2015-16.

The Review application was earlier rejected by this authority as the applicant was absent. The applicant filed Writ Petition No. 11817 of 2016 decided on 30/11/2016. The Hon'ble High Court directed this Authority to hear the Applicant. Accordingly the Review application is fixed for hearing. On behalf of the applicant Mr. Siddiqui, the treasurer of the applicant Dr. Zakir Hussain Education Society Nanded's Aurangabad Nursing School, Aurangabad is present.

According to the applicant the denominator factor is 20. Since the course RANM is of 2 years duration, the denominator factor has to be 40. This is the reason for reduction of the fees.

The Authority has reconsidered the proposal submitted by the applicant along with the Auditor's report. The Total expenditure shown is Rs. 14,22,908/-. The sanctioned strength of the student is 40. The actual fees comes to Rs. 38,340/- including development charges. The Shikshan Shulka Samiti fixed the fees at Rs. 41,477/-.

The applicant has submitted revised Auditors report. Strangely, no date is appearing on the revised Auditors report. The document is after thought.

In view of the above this Authority is of the view that the Review Application has no merit.

Hence dismissed.


