Item No.4 : Any other matter with the permission of the Chair.

(1) Justification to collect interim fee :

It has come to the notice of the Authority that some managements without submitting proposal for upward revision of fees for the A.Y. 2016-17, have been charging interim fee. This is not permissible.

Under Section 14(1) (b), in the event of non submission of proposal for upward revision of fees, the fees structure applicable during previous academic year shall apply. Numbers of institutes have opted for retaining previous academic year's fees by not seeking revision of fees for the A.Y. 2016-17. However, at the same time they have adopted interim fees structure which is contrary to section 14 (2). Interim fees structure is for those institutes who have applied for upward revision of fees for the particular academic year. Without submitting proposal for upward revision of fees for the A.Y. 2016-17 fees applicable shall be the fees approved for the previous academic year. That means if no revision of fees for A.Y. 2016-17 is sought fees structure applicable in such case shall be the fees approved for the A.Y. 2015-16 and not the interim fees declared under section 14 (2) for A.Y. 2016-17.

Collection of interim fee is only permissible when proposal for final determination of fees for the particular academic year is pending.

Managements are hereby requested to take note of this and rectify mistake immediately.
