**Item No. 4 :** **To discuss and decide for finalization of format for fixation of fees for the AY 2016-17 & 2017-18.**

In order to secure in-depth information from the institution, it was decided to make modifications in the format which is being followed presently. In that regard sub-committee was appointed. The sub- committee took pains in going to the root of the matter. It examined pros and cons of the issue involved and came out with the blue print of the revised format.

After due deliberation and with certain changes/ or (as it is) this Authority has decided to approve it. Same shall appear on FRA's website with instructions that, henceforth institutions shall submit fees proposals in the revised format.

It is further resolved that in the event any practical difficulty arises or ambiguity is noticed in implementation or in securing data as required in the different columns of the revised format; and if in the opinion of the Chairperson it is expedient to remove ambiguity so noticed or in his opinion it is necessary to explain, interpret or delete any

term in the format, he shall have power to do so after ensuring that no substantial change occurs therein and after consultation with members of the sub-committee.

**Explanation :-** To the extent of changes appearing in the formats but not in conformity with norms, the norms to that extent shall stand modified. Put it differently, changes made in the format shall prevail over the norms in vogue.
