Shri Sanjay Kumar, Member Secretary and Secretary, Higher and Technical Education, Govt. of Maharashtra and Shri S.B. Bhagwat, Member could not attend the meeting. Hence, leave of absence granted.

Shri P.E. Gaikwad, Office Secretary, Shikshan Shulka Samiti was present in the meeting.

Mrs. K.V. Sane, Desk Officer, Shikshan Shulka Samiti, Mumbai was present in the meeting.

The copies of the agenda along with copies of the relevant documents were circulated to the Members.

**Item No. 1: To consider and decide the Review Application received from following colleges for fixation of fees for AY 2012-13.**

**Item No. 1(a): EN6766 : Phaltan Education Society's College of Engineering, Thakurki, Satara.**

Heard the Institute.

The College/Institute has given notice dated 8/5/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

The fee declared for 2012-13 course was Rs. 42,370/-. It is only pointed out that there is some error in calculating depreciation. In fact it was admitted that it was an error on the part of the college while claiming the depreciation. The amount was wrongly mentioned. If calculated properly then the fee would exceed to some



extent Rs. 45,000/-. But the college has given letter dated 21/5/2013 stating that they may be allow to charge Rs. 45,000/-. We allow the same. Office to declare it.

**Item No. 1(b): EN3423 : Shree L.R. Tiwari College of Engineering, Mira Road, Mumbai.**

Heard the Institute.

The College/Institute has given notice dated 13/5/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

The fee declared for 2012-13 courses was Rs. 62,820/-. For the course 2011-12 was Rs.60,000/-. The Institute has demanded Rs. 67,500/-. The only error pointed out is in respect of considering building usage charges. It is stated that it should not have been considered for 480 students, but for 545 students. It is correct. If considered the fee exceeds to some extent Rs. 63,000/-. Institute has claimed Rs. 63,000/- by its letter dated 21/5/2013. We grant the same. Office to declare.

**Item No. 1(c): EN2139 : Savitribai Phule Women's Engineering College, Sharnapur, Aurangabad.**

Heard the Institute.

The College/Institute has given notice dated 4/5/2013 to the students/parents as per our regulation, but none is present. Notice is produced.

After discussion they pray for withdrawal of this revision. The letter for withdrawal is also given. Allowed to withdraw.

**Item No. 1(d): MB1109 : Chaitanya Bahu Uddeshiya Sanstha's Institute of Management Studies, Anjangaon, Amravati.**

None is present on behalf of the applicant inspite of giving notice in writing. Hence rejected.

**Item No. 1(e): EN2129: M.S. Bidve Engineering College, Latur.**

Heard the Institute.

The College/Institute has given notice dated 6/5/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

The fee declared for the course started during 2011-12 was Rs. 45,920/-. For course started during 2012-13 it is Rs. 50,000/-. The Institute has demanded Rs. 57,000/-. Only point argued is that there was an error to deduct 5 % of the salary. There is some error in it. If considered properly then in that event the fee exceeds to some extent Rs. 51,000/-. But the Institute has given letter dated 21/5/2013 stating that the fee may be increased by Rs. 1000/- We allow the same. The fee would be Rs. 51,000/-. Office to declare it.



**Item No. 1(f): EN5164: P.S.G.V.P. Mandal's D.N. Patel College of Engineering, Shahada, Dist. Nandurbar.**

Heard the Institute.

The College/Institute has given notice dated 10/05/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

After discussion they pray for withdrawal of this revision. The letter for withdrawal is also given. Allowed to withdraw.

**Item No. 1(g): AR4218: IDEAS- Institute of Design Education & Architectural studies, Nagpur.**

Heard the Institute.

The College/Institute has given notice dated 7/5/2013 to the students/parents as per our regulation, but none is present. Notice is produced.

After discussion they pray for withdrawal of this revision. The letter for withdrawal is also given. Allowed to withdraw.

**Item No. 1(h): EN5382: Shri. Chhatrapati Shivaji Maharaj College of Engineering, Nepti, Ahmednagar.**

Heard the Institute.

The College/Institute has given notice dated 7/5/2013 to the students/parents as per our resolution, but none is present. Notice is produced.

The fee declared for the course started during 2012-13 was Rs. 30,000/-. The Institute has demanded Rs. 55,000/-. The only error pointed out is not considering the depreciation properly in respect of equipments, books, computer etc. It is submitted that due to an error on the part of the institute, it was not claimed and hence it was not considered. It is prayed that the same may be considered. It is further stated that it is not possible to run the college on such small fee of Rs. 30,000/-. If depreciation is considered, the fee would exceed to some extent of Rs. 35,000/-. The Institute has given letter dated 21/5/2013 stating that the fee of Rs. 35,000/- may be approved. We approve the same. Office to declare it.

**Item No. 1(i): D4266: Central India Institute of Pharmacy, Nagpur.**

To be taken on 23/5/2013 as demanded by the college because there are some other colleges of the same institution are to be heard on that day.

**Item No. 1(j): EN/ME6276: Maharshi Karve Stree Shikshan Sanstha's Cummuns College of Engineering for Women, Pune.**

It is only pointed out that there was an error on the part of the earlier Chartered Accountant in finalizing the audit statement while mentioning the salary part. It is stated on behalf the institute that revised return has been filed with the Income Tax department and Charity Commissioner. It is prayed that the same may be considered for calculating the salary and the fee. It is further stated that the said return would be submitted to the Samiti before 31/5/2013. If the fee to be recalculated in that event. If not submitted then there is no error whatsoever in calculating and declaring the fee for 2012-13 of Rs. 23,580/- and none is pointed out. In that event this revision to stand dismissed.
