Item No. 3(a): To discuss and decide on proposals where there are no discrepancies.

The Samiti considered the proposals of the following Colleges/Institutes for finalization of fee structure for the students who joined the course started during Academic Year 2015-16. After deliberations, the Samiti decides to approve the final fee structure of the following Colleges/Institutes for the students who joined the course started during Academic Year 2015-16, subject to final approval/affiliation/permissions from respective Authorities. Figures are arrived at after considering the calculations drawn in the worksheet – calculation sheets of the respective colleges/institutes prepared by a Chartered Accountant. The students admitted in Academic Year 2015-16 and there after continuing their studies will pay an enhanced fee of 5% each successive year as per the norms for 2015-16 till completion of the course. For example if the fee approved is Rs. 1,00,000/- then from II<sup>nd</sup> years onward till completion of the course i.e. say II, III and IV year the fees will be Rs. 1,05,000/- per @. In case the students take V<sup>th</sup> years for completing the course then he shall pay the fee approved in that year. Worksheet - Calculation sheets are available in the office.

- 1) The students are permitted to file revision against the fee approval. Therefore, there can be no separate consideration of such complaint.
- 2) The fees are approved on the basis of the Norms and as per the Law.
- 3) The allegations against the Samiti of fraud of Rs. 5000 crores. The Hon'ble Chief Minster may take the decision. The Samiti denies all the allegations made in the letter and strongly condemns the allegations. We also submit that Government to take legal action as deemed fit against the signatories of the letter. They are trying to mislead the state and defame fee Samiti which has been functioning for nearly ten years. . It is not within the purview of the Samiti to check the details of staff according to rules.
- 4) There is an allegation of collecting fees illegally from the students by Saraswati Dhnwantari Dental College, Parbhani and other colleges. It is to be noted that such complaint was made by students of Saraswati Dhnwantari Dental College, Parbhani. But it was taken back. We give no credence to the allegations made.
- 5) There is a demand for dissolution of this Samiti. The Hon'ble Chief Minster can take the decision about it.
- 6) The fee approval of both Medical and Engineering colleges is quite transparent. Nothing is hidden from the stake holders.
