**Item No. 3:** **To discuss and decide the Review Applications received from following colleges for approval of fees for Academic Year 2014-15:-**

**Item No. 3(a):** **BAMS0026 : Mahadeorao Shivankar Ayurved Medical College, Kudwa, Gondiya**

There is a email received from the aforesaid Institute which says as under :-

*"So, You are hereby requested to take the decision for the same or give us another chance to appear before your in future. Thanking you,"*

This is in respect of fees decided for the course started during Academic Year 2014-15. On earlier occasion the revision was withdrawn as there was technical difficulty and the college was allowed to file fresh one on 22<sup>nd</sup> January 2015. We have considered fresh revision file on 27/02/2015. It contains no ground for revision of approved fees. Hence rejected

**Item No. 3(b):** **RGNM0016 : Sahara Institute of Nursing, Aklunji**

Samiti heard Mr. Rahul Jawanjaj, Secretary on behalf of the aforesaid College/Institute.

He prays for withdrawal of this revision. Allowed to withdraw.

**Item No. 4:** **To discuss and decide on the letter dated 18/11/2014 and 10/2/2015 received from Dr. Wasudev B. Durge and Dr. PDM Medical College Amravati submitting Affidavits & replies in respect of financial irregularities and manipulations. (Ref: Item No. 3 Minutes of the Meeting dated 8/4/2015).**

Samiti heard to Dr. R.R. Soni and Ms. N.S. Jawandhiya, Chartered Accountant on behalf of the College/Institute

This is in respect of the decision taken by the Samiti in its meeting held on 8<sup>th</sup> April 2015 at Item No. 3.

The College/Institute has submitted huge documents before the Samiti. We considered the whole thing, Prima facie we believe that the College was involved in huge cash collection i.e. in the Trust account which was opened on 15-03-2011 till 31-03-2011. The cash deposited was Rs. 3,92,92,520/- and the amount transferred to the different institutes. The balance amount as on 31-03-2011 was only Rs. 1,37,454/-. It is observed that huge amount of cash deposited even in subsequent years. In trust account and cash donations are collected in the society's account which was subsequently transferred to Medical College Account . We therefore feel that it needs thorough investigations, Third agency is also involved in this i.e. Bank of Alahabad, Amravati. We do not have jurisdiction to go through it account as it is



beyond the purview of the Samiti Account of the Society/College in Alahabad Bank. We request the Government of Maharashtra – Medical Education and Drugs Department, Mantralaya, Mumbai to investigate thus thorough its criminal investigations wings and also to request Income Tax Department to find out the truth about the high donations in cash to the society. This also relates to transaction in society accounts which need to be investigated.

We are also in receipt of complaints from Dr. Wasudev Bhagwanji Durge, Dadarao Panjabrao Patil and Subhash Bhanudas Sable.

The scrutiny was done by us because of our earlier decision particularly dated 8<sup>th</sup> April 2015 at Item No. 3.

Office to write and also send the copies of the complaints for further action along with the documents received to the Government of Maharashtra.

**Item No. 5:** **To discuss and decide on the letter dated 24/3/2015 received from Pad. Dr. Vithalrao Vikhe Patil Foundataion's Medical College, Ahmednaqar regarding Repeater fees of PG Medical Students (Ref. Item No. 5(ii) a Meeting dated 25/2/2015).**

Considered the letter from the Colleges dated 13-04-2015 and email dated 3/3/2015. They are on the same lines. While declaring the fees there was error not mentioning in RGNM course. It is only RGNM course mentioned. Office to correct the declaration made on 22/12/2014 and 2/12/2014, respectively.

Instead of mentioning 'Harsh School of Nursing, Khamgaon'. The mention made is 'Manik School of Nursing, Buldhana'. Office to correct the declaration.

There are three letters dated 19/03/2015 received from Asst. Commissioner, Social Welfare Department, Nagpur in respect of 03 Colleges/Institutes viz. - (a) : Mother Teresa Nursing Institute, Nagpur, (b) : Right Value Institute of Nursing, Nagpur, (c) : Tanishq School of Nursing, Nagpur.

Certain deficiency was noticed when there was investigation was carried out by the said department. However we request Registrar, Maharashtra Nursing Council, Mumbai to make a report about it and send copy thereof to the Samiti for enabling the Samiti to take further steps. The copies of this letter also to be send to the Maharashtra Nursing Council, Mumbai received from the said department.

There is one more letter dated 19/03/2015 in respect of Central India Nursing College, Nagpur. The letter mentions that the said college was found to be closed, when inspection was made on 27/02/2015. There were no students or employees. Therefore no action can be taken by the Samiti in respect of this college.



The copy of this letter to be sent to the Maharashtra Nursing Council, Mumbai along with the letter from department. The council to enquire about it since the fee of this college was approved by the Samiti for Academic Year 2014-15. The said council is requested to send the copy of its report to the Samiti early.
