Item No. 3 : **To decide on the proposals received for approval of fees structure for the courses started during Academic Year 2014-15:**

Item No. 3(a) : **To consider and decide on proposals where there are no discrepancies.**

The Samiti considered the proposals of the following Colleges/Institutes for finalization of fee structure for the students who joined the course started during Academic Year 2014-15. After deliberations, The Samiti decides to approve the final fee structure of the following Colleges/Institutes for the students who joined the course started during Academic Year 2014-15, subject to final approval/affiliation/permissions from respective Authorities. Figures are arrived at after considering the calculations drawn in the worksheet – calculation sheets of the respective colleges/institutes prepared by a Chartered Accountant. The students admitted in Academic Year 2014-15 and there after continuing their studies will pay an enhanced fee of 5% each successive year as per the norms for 2014-15 till completion of the course. For example if the fee approved is Rs. 1,00,000/- then from IInd years onward till completion of the course i.e. say II, III and IV year the fees will be Rs. 1,05,000/- per @. In case the students take Vth years for completing the course then he shall pay the fee approved in that year. Worksheet – Calculation sheets are available in the office.

Item No. 4(i): To consider the letter dated 10/11/2014 bearing संकीर्ण- १०१४/सं.क्र. १५७४/१४/शिक्षण-२ received from Medical Education Department Mantralaya forwarding an application of Kum. Shradha Devidas Rajguru against Dr. Vitthalrao Vikhe Patil Medical College in connection with return of her Original Certificate.

Considered the letter dated 10/11/2014 received from the Desk Officer Medical Education and Drugs Department, Government of Maharashtra, accomplishing the letter Mrs. Maya Devidas Rajguru dated 25/9/2014 addressed to the Hon'ble Governor of the state of Maharashtra. It is about Nursing course. The office to call for the report from the college i.e. Dr. Vitthalrao Vikhe Patil Medical College which conducts the Nursing course. The daughter of the applicant had taken admission. Under circumstances such as harassment of the said daughter by some 3 persons, she was compelled to withdraw her admission. She belongs to the reserved category. Under such circumstance the college to consider the request of the student sympathically to return the original documents such as marksheet etc. submitted to the college immediately. The reply to be sent within the period of 2 weeks of the receipt to the letter.

Item No. 4(ii): To consider and decide on letter dated 27/10/2014 received from Dadasaheb Surupsing Naik Ayurved Mahavidyalaya in respect of charging fees from Repeater and failed students.

Item No. 4(iii): To consider and decide on letter dated 29/10/2014 received from Dadasaheb Surupsing Naik Ayurved Mahavidyalaya asking Mr. Devidas Madhavrao Patil and other parents to pay in 3rd year B.A.M.S. entrance and advance fees.

Item No. 4(iv): To consider and decide on letter dated 13/10/2014 received from Dadasaheb Surupsing Naik Ayurved Mahavidyalaya asking guidance in respect of charging penalties and interest for late payment of fees.

These are on the same lines and common reply can be given. Considered the letters dated 27/10/2014, 29/10/2014 and 13/10/2014 of the college. The Samiti had already taken the decision about the same college in the meeting held on 8/11/2013 at Item No. 6 (a) it is as under:-

" Item No. 6(a) : To consider and decide on the letter dated 10/10/2013 received from the Dadasaheb Surupsingh Nayik Ayurved University , Dhule in respect of fixation of fees for repeater students. (Ref : Item No. 5 (d) of minutes 10/1/2012).

Considered the letter dated 10/10/2013 received from Dadasaheb Surupsing Naik Ayurvedic Mahavidyalaya, Dhule. It is in respect of fee to be collected from repeater students. The College can collect the fee from such students pro-rata of the failed subjects (for example if the fee is Rs. 1,00,000/- and there are five subjects, if a student fails in two subjects and it required to appear again for these two subjects, then college can charge Rs. 40,000/-) for which they are required to appeared again. The fee is for the course and in case students is not able to complete the course within stipulated time, then College/Institute can charge the fee which is declared for the next course. For example the B.A.M.S. course is 4 ½ years, if the fee declared for Academic Year 2011-12 is Rs. 1,00,000/- then it will continue for 4 ½ years. But thereafter it will apply the fee which is declared for the course started in Academic Year 2015-16. The norm provides as under :-


"1.5 The students admitted in the Academic Year 2013-14 and there after continuing their studies will pay an enhance fee of 5% till the completion of the course (during the stipulated period of the course). For example if the fee is approved is Rs. 1,00,000/- then from IInd years onward till completion of the course i.e. say II, III and IV year the fees will be Rs. 1,05,000/- per @. In case the students take Vth years for completing the course then he shall pay the fee approved in that year."

The actual collection of fees to be done by Institute and Samiti is not concerned with it. Office to inform." It is not for the Samiti to tell the college how to recover the fees from those repeater students who are not paying it, but one thing is clear that the Samiti has no norm that the college can charge interest or penalty if the fee is not paid or there is a delay. The college is free to take steps in this respect as per law.
